Discussion:

Across the country stations are trying to remove programmers from the Board due to the potential conflict of interest. We are bringing back programmers' opportunities for member seats with this election.

We are reviewing whether to limit the Board Positions of President and Vice President leadership to appointed Directors and not Elected Members.

Questions of behavior by Directors and their boundaries need to be clarified under policies and procedures. Past interference with staff and administration of KAFM's operations are examples of boundaries that still need to be defined, clarified, and placed in policy.



We will table future decisions for after the special election when a more fully constituted Board is seated.

Treasurer's Report

Presented by Tami for Julia. Highlights include the year-to-date Budget vs. Actuals. The figures are drawn from the reconciled budget through the end of May 2024. This is 5 months into the fiscal year.

Payroll was over due to three payrolls in a month and additional ED salary payout.

Spring Drive expenses were over due to packages offered as incentives in March.

Total revenue income is over projected budget for the year by almost 5%

Total expenditures are over projected budget by 7%
